On 29 November 2019, the shareholders approved the Company to issue a convertible note to Rich Mark Development (Group) Pty Ltd, which replaced the loans advanced to the Company by Rich Mark (Group) Pty Ltd as well as two additional tranches of \$500,000. One of these were advanced on 31 January 2020 and the other is to be advanced on 10 April 2020. The convertible note will have a face value of up to \$6,416,009 (comprising the \$5,000,000, being the total outstanding principal of the current loans, plus accrued interest), it is unsecured with a maturity date of 6 December 2022 at a nominal interest rate of 6% per annum.

In the 2016 financial year the major shareholder of the Company, Xingang Resources (HK) Ltd, extended a loan facility of \$4 million. The loan is unsecured, repayable at 31 December 2021 with an effective interest rate of 10% per annum.
